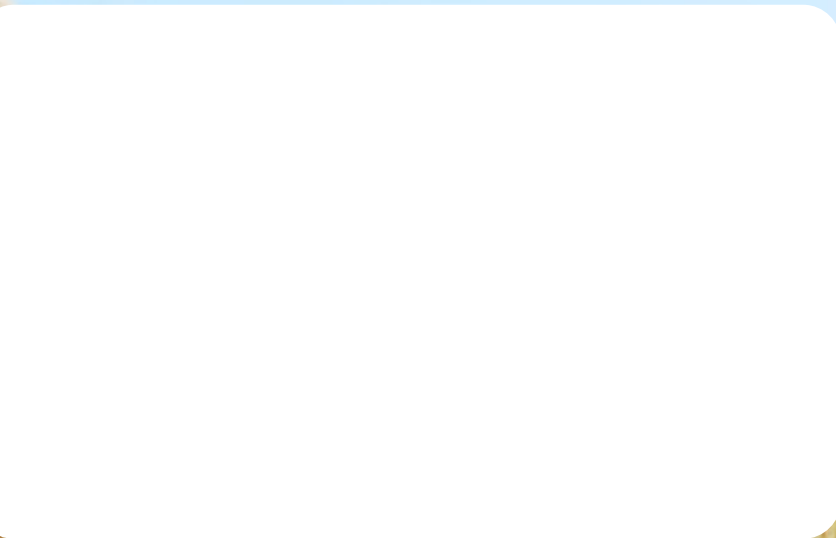

- Regular price indicators and dynamics of the land market, at regional and sub-regional level

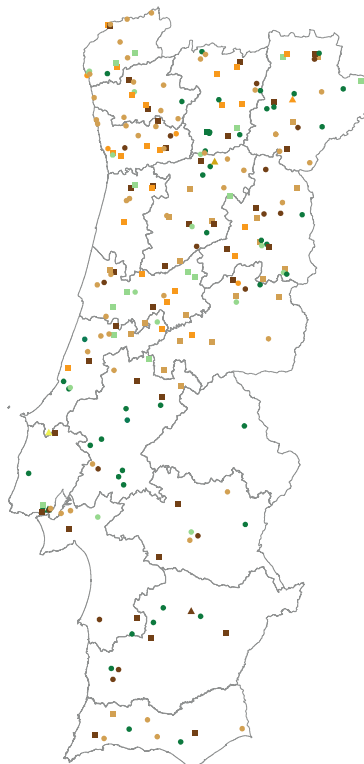
# GeOp

## Land offer

### Through the information system (SiBT), the owners:

- Perform their user registration
- Insert the data from their land and attach documents
- Select a GeOp covering the geographic location of their land
- Send data for validation
- Obtain the Contract of Availability of their land

### Through a GEOP, the owners:

- Receive technical support in order to introduce the data of their land and to promote its availability in the information system (SiBT)

## Land search

### Land from private entities and other entities

In case of finding a land that matches your needs, establish direct contact with the owner using the available contact means on the information system. Generally it's not necessary to register as a user, but it is recommended to read the access conditions.

### Land from other entities

In case of finding a land that matches your needs, check the access conditions or request information using the available contact means on the information system.



## Incentives

### Reduction of costs in registration acts

The payable fees for carrying out registration acts of facts relating to land to be made available, or already available, in the National Land Bank for agricultural and forestry production, are reduced by 75%.



## Incentives PDR2020

For the purpose of selection of candidates, it is considered as a priority criterion the candidacy of young farmers who have acquired ownership of farmland or of any of its units through the National Land Bank.
